There is no limit to the number of entries.

Entries:

Closing date: All entries should reach Selangor Amateur Fencing Association (SAFA) , by noon on 31st May.2015.

All entry fees shall be paid either cash or cheques before 8:45am on 20th June, and fees are to be submitted by Team Managers or representative in total amount, no individual payment is allowed.

Entry Fee:

The rate of entry fee is RM100 per person per event.

Referee

The delegations must submit a specific number of referees to the Technical Board of Directors, according the following table:

- . 1 – 4 Fencers - 0 Referee
- . 5 – 8 Fencers - 1 Referee
- . more than 8 Fencers - 2 Referee

These referees are to be on duty under the assignment of the Directorie de Technique throughout the competition. If the participating delegation fails to provide the required number of referee, a penalty fee of RM150.00/per day/per referee will be imposed. The fee should be paid before the start of the competition on the day.

Competition Methods:

The fencing competition shall be conducted in accordance with the current Statues and Rules of the FIE. In case of disagreement in interpretation of the Rules, the latest English version shall prevail. The Directorie de Technique shall deal with any unforeseen incidents not covered by the Rules.

Equipment:

FIE equipment is not compulsory, however, rusty weapons, torn fencing attire and short socks are not allowed. Fencers' clothing must be made of sufficiently, robust material and be clean and in good condition. Jacket, breeches and Inner plastron must be at least 350N. **Weapon check will be done on the piste before each bout.**

Prizes:

Medals will be awarded to the 1st, 2nd and joint 3rd places in each event. Certificate of Participation will be presented to all participants.

Competition Management

Directorie de Technique (DT)

The DT shall be responsible for the technical organisation of the competition.

Jury of Appeal

The Jury of Appeal shall consist of one representative from each participating state/club under the chairmanship of the Organising Chairman, or a representative appointed by hi. The decision of the Jury of Appeal shall be final.
